PHARMACY EDUCATION IN PAKISTAN - NOC OF PHARMACY SUBJECT: TECHNICIAN PROGRAM

Please refer to the subject cited above.

2. It is to inform that the team of the Pharmacy Council of Pakistan, Islamabad visited the said College on 5-2-2021 to verify the required facilities for grant of NOC of the Pharmacy Technician Program. The report of the visiting team was placed before the Council for consideration in its recently held 47th meeting dated February 13, 2021, hence the Council unanimously approved 100 (one hundred) admissions/ annum (50morning + 50evening) with the following terms & conditions.

Terms & Conditions:

- a) The NOC is for the maximum period of three (03) years after that a renewal will be required with prescribed fee.
- b) The College shall fully abide by the rules and regulations enforced by the Pharmacy Council of Pakistan at present and those which may be enforced at any time in future.
- c) The College shall fully abide by the decisions of the Pharmacy Council of Pakistan which are issued time to time.
- d) That the approved facility/premises by the Council shall exclusively be used for Pharmacy Technician Program only and that the approved entire facility or its portions shall not be shared/used with any other diploma/program.
- e) The teaching programs are in accordance with the approved syllabi of Pharmacy Council of Pakistan, Islamabad and that due provision is made for the instructions, health, recreation and discipline of students.
- f) The College maintains a library as per minimum requirements with relevant books, journals, articles, catalog, etc administrated by the professional/skilled librarian.



- g) The College maintains the computer lab as per minimum requirements. That the computers are in working condition with the facility of internet, scanner, copier, printer, etc and administrated by the computer instructor.
- h) The College maintains, all the laboratories as well as stores as per minimum requirements of the Council with equipment, chemicals, glassware, infrastructure, etc administrated by the lab instructor.
- The teaching faculty conforms to the standards as prescribed by the Council Regulations and the College shall engage at least 70% whole time teachers for each category.
- j) The College will immediately inform any change/modification in the teaching faculty and position of the Principal.
- k) All employees, whether temporary/permanent or visiting are employed on a written agreement stating salary the terms and condition on which they are engaged.
- The College will immediately inform any change/modification in the physical facilities. In case of shifting the facility, the College will immediately inform and seek fresh approval for new premises.
- m) The College shall get the students registered with the relevant Provincial Pharmacy Councils within sixty (60) days of their admissions under intimation to this Council.
- n) The approval to conduct the training program may be withdrawn or modified if the College fails to continue to satisfy the conditions of the said approval or if the training is conducted in a manner, which prejudice to the interests of pharmacy education.
- o) The College will pay the renewal fee within time frame.
- p) The College may be inspected from time to time by the Pharmacy Council of Pakistan or relevant Provincial Councils constituted by center for the purpose and the Council shall take appropriate action on any genuine complaint.
- q) The College shall strictly abide by the admission criteria as specified from time to time by submitting its students so enrolled after the closing date of admission as announced for every preceding year and shall not sublet wholly or partly its students or portion of premises to anyone.
- r) The teams of the Council may conduct the surprise visits of our College without further/prior notice to evaluate the compliance status of the College. Failure to compliance/ adherence may lead to withdrawal of NOC or any other penalty approved by the Council.
- s) The Council has the legal right to revoke/withdraw the permission of admissions if it observes any violation or non-compliance to the regulations/ instructions issued by the Council from time to time.
